PLEDGE GOAL: \$180,000

What is a pledge? It is a promise to give a certain amount of money to SUUS for the upcoming fiscal year (July 1, 2020 – June 30, 2021)

Do I need to be a member to make a pledge? Anyone can give to SUUS. Those who pledge/donate and have not yet chosen to become Members are known as Friends, and are able to take advantage of what SUUS has to offer, except for voting at congregational meetings and holding leadership positions.

Do I have to make a pledge to be a member of this congregation? Yes, an annual pledge is required to be a voting member. The financial health of this community is the responsibility of every member. Remember, there is no SUUS without your contributions of passion, time, and money.

How much should I give? This depends on your personal finances and your commitment to making this congregation sustainable now and for future generations. We all need to increase our level of giving in order to decrease the draw on our endowment, to maintain our full-time ministries, expand our programming, and improve our facilities.

What about non-cash gifts? You may donate stock, IRA distributions, or other securities directly to SUUS, and there can be tax advantages. Please contact the treasurer or the office for asset transfer instructions.

Are monetary gifts to the church tax-deductible? Pledge payments and donations to SUUS are tax-deductible for the calendar year in which they are given. We suggest consulting with your financial advisor for more information.

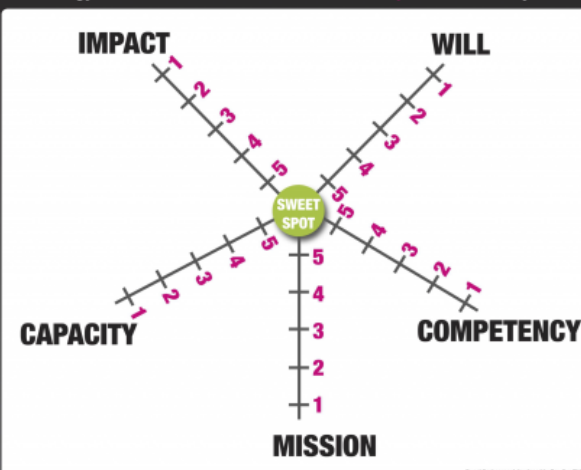

You have a lot of ideas... How do you choose where to focus your energy and resources? That's what the **Sweet Spot tool** does for you!



DIRECTIONS:

For each project or program idea, assess where you fall in five areas:

- How strong is the **WILL** of your team to carry this out?
- What level of **COMPETENCY** or skill does the group possess for this project?
- How well does the idea align with your **MISSION**?
- How much **CAPACITY** (time, money, volunteers, etc.) do you have to get it done?
- What degree of **IMPACT** will the project have if you complete it?

The closer everything gets to 5, the sweeter your ideal!

5 = Best possible
4 = Good
3 = Sufficient
2 = Low
1 = (almost) Non-existent

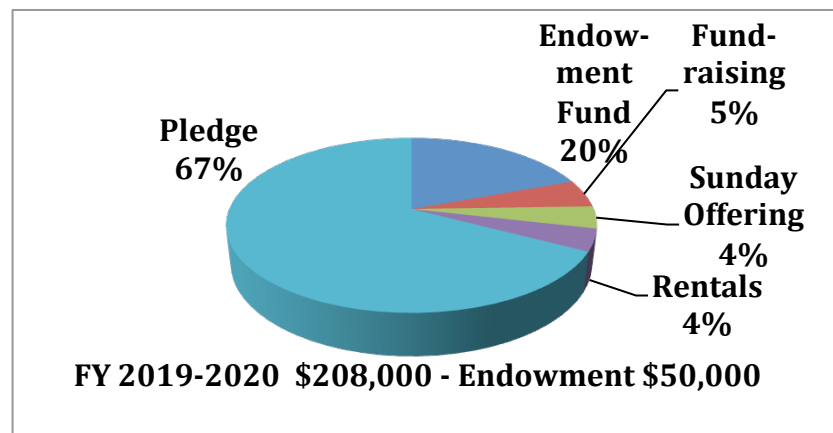
